Whereas, I have the reason to believe that due to prevailing Law & Order situation in the Examination Centres, there are sufficient grounds for taking precautionary measures for prevention of the occurrence of any untoward incident in the interest of maintaining peace & tranquillity within the Examination area/ Examination Centre.

Whereas, after careful examination of all facts, I am satisfied that there are sufficient grounds for promulgation of the prohibitory order U/S 144 of the Criminal Procedure Code, 1973 for maintaining public safety from 08:00 AM to 06:00 PM in and around the Examination Centres.

Whereas, the candidates appearing for the H.S.L.C Examination, 2024 are restricted to enter into the premise of the Examination Centre with the following items:-

- 1. Electronic gadgets.
- 2. Digital watch/Calculators.
- 3. Any kind of study materials.
- 4. Mobile phone.
- 5. Any gadgets or materials which can be used to disturb the process of free and fair examination in the centre.

Therefore, considering the exigency of the matter, I, Sri Lachit Kumar Das, ACS, District Magistrate of Hojai district do hereby promulgate of the prohibitory order U/S 144 CrPC, 1973 from 12th February, 2024 to 13th March, 2024 within 100 (hundred) meters from Zero point of Examination Centres restricting following activities.

- 1. Use of loud speaker in and around the examination centre.
- 2. Gathering of crowd in and around the centre.
- 3. Organization of any Fair, Sports, Religious convention/Competition in and around the examination centre.

Violation of the promulgation will be punishable under relevant provision of Law.
