PROHIBITORY ORDER U/S 144 Cr.P.C.

Whereas there is ample apprehension of disturbance of public peace and tranquility, endangering life and property of public in the District of Hojai in view of the Independence Day 2022 and prevailing situation

Whereas, I am of the opinion that issue of prohibitory order under Section 144 Cr.P.C. is felt necessary with a

view to maintain public peace, security and tranquility.

Now, therefore, I, Anupam Choudhury, ACS, District Magistrate, Hojai in exercise of power conferred upon me U/S- 144 (1) Cr.P.C. do hereby promulgate prohibitory order banning the following in the interest of maintenance of public peace and tranquility in the District.

 Use of mike/loud speaker/music system/deck either in fixed mode or in the vehicles when plying on roads are prohibited.

2. Assembly of five or more persons in any public place intending demonstration/meeting/procession etc except

for religious festivals. 3. Carrying of lethal weapons and arms in public places including lathis, daggers, sticks, spears, swords, etc.

4. Holding of rallies, meeting, public rally, procession, demonstrations, dharnas, shouting, slogans, gathering in public place without permission.

Effigy burning, in Govt/Semi-Govt. land.

Forcible collection of fund from public/lotteries/ Gambling at public places.

- 7. Bursting or throwing of crackers etc. inflammable materials on the street or on public/ pedestrians/ moving or stationary vehicles etc.
- 8. Inflammatory speeches, communal or anti-state/anti-national speeches/slogan banners/postering/wall writing etc.
- 9. Use of tinted or opaque glasses (Dark Glasses)/vacuum horns, and driving with high beam lights in all vehicles.

10. Wearing of any dress resembling Army fatigue by individual other than Army/ Para Military forces.

Owing to the necessity of the situation, this order is passed ex-parte under section 144 (i) Cr.P.C. However anyone aggrieved by the order may approach the competent authority for modification/ waiver rescind of the order. This order comes into force with effect and will remain in force until further order. Any violation of this order is punishable U/S 188 IPC.
