**ORDER**  
(U/S 163 of BNSS)

Whereas, there is a proposed visit of **Shri Narendra Modi, Hon'ble Prime Minister of India, to Hojai District on 06<sup>th</sup> April, 2026**, along with a scheduled public meeting at Srimanta Sankardev Nagar Playground, as well as the use of the designated temporary helipad at Borboha Field, Hojai.

And whereas the use of Drones, Unmanned Aerial Vehicles (UAVs), Balloons etc. may pose a potential threat to the safety and security of the VVIP, general public, and critical installations;

Therefore, I, Sri Deba Prasad Misra, IAS, District Magistrate, Hojai in exercise of powers conferred upon me U/S 163 BNSS do hereby order as follows:

1. No Drone, Unmanned Aerial Vehicles (UAVs), Balloons etc. shall be operated within a radius of **three (3) kilometres** from the **Srimanta Sankardev Nagar Playground** (meeting venue), including the designated temporary helipad area at **Borboha Field, Hojai**, on 06<sup>th</sup> April, 2026, without prior permission from the competent authority.
2. This restriction shall remain in force for the entire duration of the Hon'ble Prime Minister's visit.
3. Any violation of this prohibitory order will invite penal action **U/S 223 of Bharatiya Nyaya Sanhita, as well as legal action under applicable laws.**

Owing to the necessity of the situation, this order is passed ex-parte under section 163 of Bharatiya Nagarik Suraksha Sanhita. However, anyone aggrieved by the order may approach the competent authority for modification/ waiver of the order. This order comes into force with immediate effect.
