ORDER
(U/S 163 of BNSS)

Whereas, it has been made to appear before me that vehicles are plying recklessly over the National Highway and State Highway roads and there is an increase in number of cases of violation of Motor Vehicles Act;

Whereas, the fatalities in Road accidents has increased and injured persons number are also alarmingly high since last few weeks;

Whereas, it has been made to appear before me that vehicles are running on road using modified/enhanced music system creating sound pollution and risking life and property;

Whereas, there is every likelihood of increase in number of road accidents due to poor visibility foggy condition;

Therefore, I, Sri Bidyut Bikash Bhagawati, ACS, District Magistrate, Hojai, in exercise of powers conferred upon me U/S 163 BNSS do hereby promulgate the following prohibitory orders.

1. Movement of Dumpers is restricted on National Highways and other state roads from 05:00 PM to 08:00 AM.
2. Movement of e-Rickshaws is restricted on the State Highways/Rural Roads from 05:00 PM (evening) upto 06:00 AM.
3. All types of Heavy Motor Vehicles speed limit are restricted to 40 Km/hr and Light Motor Vehicles speed limits are restricted to 60 Km/hr at National Highway.
4. All types of Vehicles speed limit are restricted to 40 Km/hr in Municipal Board/Rural areas.
5. All types of vehicles are prohibited from modifying or using any types of DJ sound system at National Highway and State Highway roads.
6. All types of goods carrying vehicles are prohibited to be used for picnic purpose/carrying passengers.
7. All types of bike stunts or any type of stunts performed in National Highway or State Highway road, penalties will be imposed with fine and immediately cancellation of licence.
8. Drinking & Driving, Wrong Side Driving, Overspeeding or any other violation of Road Safety measures will result in fine imposition and strict action will be taken according to the Motor Vehicles Act.
9. No fuel will be issued to any person/pillion riding 2-wheeler without helmet for both driver and pillion (No Helmet No Fuel).
10. Parking of Vehicles at roadside specially on front of Petrol Pump at National Highway stretch at Rengbeng-Lumding and Doboka-Parakhowa are strictly prohibited.

Owing to the necessity of the situation, this order is passed ex-parte under section 163 of Bharatiya Nagarik Suraksha Sanhita. However, anyone aggrieved by the order may approach the competent authority for modification/ waiver of the order. This order comes into force with immediate effect. Any violation of this prohibitory order will be punishable U/S 223 of Bharatiya Nyaya Sanhita.
