Whereas, I have the reason to believe that due to prevailing Law & Order situation in the Examination Centres, there are sufficient grounds for taking precautionary measures for prevention of the occurrence of any untoward incident in the interest of maintaining peace & tranquillity within the Examination area/ Examination Centre.

Whereas, after careful examination of all facts, I am satisfied that there are sufficient grounds for promulgation of the prohibitory order U/S 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 for maintaining public safety in and around the Examination Centres.

Therefore, considering the exigency of the matter, I, Sri Bidyut Bikash Bhagawati, ACS, District Magistrate of Hojai district do hereby promulgate prohibitory order U/S 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 **from 10th February, 2026 to 16th March, 2026 within 100 (hundred) meters from Zero point of Examination Centres (till final examination) restricting following activities.**

1. **Entry of unauthorized person or unnecessary crowding in and around the premises of Examination Centre.**
2. **Use of loud speaker, microphone etc. at night and during examination hours.**
3. **Organization of any Fair, Sports, Religious convention/Competition in and around the examination centre.**
4. **Carrying of any digital watch/calculators/mobile phone/any kind of study materials/any gadgets or materials which can be used to disturb the process of free and fair examination by the Examinees in Examination Centre.**

Owing to the necessity of the situation, this order is passed ex-parte U/S 163 of BNSS, 2023. However, anyone aggrieved by the order may approach the competent authority for modification/waiver of the order.

This order comes into force with immediate effect and will remain in force until completion of the examination process in the district.

Any violation of this order shall be punishable U/S 223 of Bharatiya Nyaya Sanhita and other relevant provision of law.
