ORDER

(U/S 163 of BNSS)

Whereas, there is a proposed visit of Shri Mohan Bhagwat, RSS Sarsanghchalak (Chief), from 13th to 17th May, 2026 to Geeta Ashram, Hojai for locally arranged programmes at Geeta Ashram, Hojai;

And whereas, the use of Drones, Unmanned Aerial Vehicles (UAVs), balloons, etc. may pose a potential threat to the safety and security of the VVIP and general public relating to the purpose of visit.

Therefore, I, Sri Bonny Inam Shadab, ACS, Additional District Magistrate, Hojai, in exercise of the powers conferred upon me under Section 163 of the Bharatiya Nagarik Suraksha Sanhita (BNSS), do hereby order the following:

1. No Drone, Unmanned Aerial Vehicle (UAV), balloon or any similar aerial object shall be operated within a radius of three (3) kilometers from the venue, i.e., Geeta Ashram, Hojai, from 13th to 17th May, 2026 without prior permission from the competent authority.
2. The restriction shall remain in force for the entire duration of the visit of Shri Mohan Bhagwat, RSS Sarsanghchalak (Chief).
3. Any violation of this prohibitory order shall invite penal action under Section 223 of the Bharatiya Nyaya Sanhita (BNS), along with legal action under other applicable laws.

Owing to the emergent nature and necessity of the situation, this order is passed ex-parte under Section 163 of the Bharatiya Nagarik Suraksha Sanhita. However, any person aggrieved by this order may approach the competent authority for modification or waiver of the order.

This order shall come into force with immediate effect.
