- 2. Bidders are to quote rates item wise/percentage basis, i.e. below or as per estimated cost.
- 3. Up to date registration certificate, GST Registration, PAN Card, Labour License, EPF Registration etc.
- 4. Amount shown is the appropriate value of works.5. Rate should be quoted at flat rates.
- 6. The Tender Committee will be the sole authority for accepting or rejecting any or all tenders without citing any reason thereof.
- The short NIT will form part of the contract agreement.
- 8. Rate should be quoted inclusive of all taxes.
- 9. GST/Cess/F.R. etc will be recovered from the bill by the competent authority as per Govt. rules.
- 10. Bidders having earlier experience of performing election related temporary construction works will be given preference. The bidders may submit their experience related documents along with the bids.
- 11. Unreasonable low bids will be rejected.
- 12. Payment will be made as and when fund is received from the Govt.
