SANCTION ORDER

In pursuance of the Govt. Sanction Letter No. FS/14_2023-24(I)_255, Dated: 17.12.2023, Administrative approved by District Commissioner of Hojai is hereby accorded for an amount of Rs. 80,00,000.00 (Rupees Eighty Lakhs) only for construction of 21 (21) No. schemes in respect of 92-Lumding LAC of Lumding Co-District under MLAADs for the year 2023-24.

Financial Sanction is also accorded for an amount of Rs. 60,00,000.000 (Rupees Sixty Lakhs) only @ 75% of the sanctioned amount for the Development of 21 (Twenty One) number of Scheme as 1st Installment (including Labour Cess, FR, MMDRR, DMFT). The works are to be completed within 3 (three) months from the date of sanction of the schemes.
