They shall also assist the concerned authorities in promoting sanitation awareness, prevention of open dumping and burning of waste, segregation of waste at source, and effective implementation of the provisions of the Solid Waste Management Rules, 2026 at the grassroots level.

This order shall come into force with immediate effect.
