## ORDER (U/S 163 of BNSS)

Whereas, in pursuance of the Notification issued vide eCF No.E-634285/04, dtd. 28/03/2025 issued from the Fishery Department, Government of Assam and letter from District Fishery Development Officer, Hojai, Assam in connection with ensuring natural breeding, propagation and growth of fish in all fisheries and natural water bodies;

And whereas State Government has notified a rule under the name Assam Fishery Rule, 1953 as amended upto The Assam Fishery (Amendment) Rule, 2005 to control and regulate the development of Fisheries in Assam;

Therefore, I, Sri Bidyut Bikash Bhagawati, ACS, District Magistrate, Hojai, in exercise of powers conferred upon me U/S 163 BNSS do hereby order as follows:-

- Use of "Berjal/Mahajal" or "Fasijal" or any type of nets with meshes less than 7 cm Bar/14 cm mesh is prohibited during breeding season from the 1<sup>st</sup> April to 15<sup>th</sup> July in any proclaimed fishery under Rule 23 (1) of Assam Fishery Rules, 1953.
- 2. The use of net with less than 1 cm Bar/2 cm mesh in size (Mosaijal) is prohibited in any fishery throughout the year under Rule 23 (2) of Assam Fishery Rule, 1953.
- 3. Prohibition on catching of brood fish of certain species in any proclaimed fishery is imposed w.e.f. 1<sup>st</sup> May to 31<sup>st</sup> July under Rule 23-A (1).
- 4. Catching and killing by any method, of fish for any purpose including consumption and selling of undersized fish of certain species is prohibited between 1<sup>st</sup> August to 31<sup>st</sup> October under Rule 23-A (2).
- 5. Any violation of this prohibitory order will invite penal action U/S 223 of Bharatiya Nyaya Sanhita as well as Assam Fishery Rule, 1953 as amended upto The Assam Fishery (Amendment) Rule, 2005, including suspension/cancellation of lease.

Owing to the necessity of the situation, this order is passed ex-parte under section 163 of Bharatiya Nagarik Suraksha Sanhita. However, anyone aggrieved by the order may approach the competent authority for modification/ waiver of the order. This order comes into force with immediate effect.
