**ORDER**  
(U/S 163 of BNSS)

Whereas, the Dy. Chief Engineer (Con), N.F. Railway, Maligaon vide letter No. W/362/CON/D-H/ROB/JMK/2025/3384, dtd. 04/07/2025, requested for issuance of temporary prohibition for heavy vehicular movement through railway level crossing no-ST/38 at Jamunamukh (JMK) yard of Doboka-Kampur road for 30 days.

And whereas, there are every possibilities of heavy vehicular traffic movement in Doboka-Kampur road due to construction work of Road Over Bridge (ROB) at Jamunamukh Railway yard adjacent to railway level crossing no. ST-38 of Doboka-Kampur road.

And, Whereas on perusal of report from the Executive Engineer, PWRD, Hojai District Territorial Road Division, Hojai vide No. EE/HDTRD/RG-ST/38/200/2025-26/03, dtd. 22/07/2025, regarding joint verification conducted by Railway officials and the Assistant Executive Engineer, PWRD, Binnakandi Territorial Road Sub-Division, I am of the opinion that there is a need for temporary road closure for HMV vehicles with a height exceeding 3 (three) mtr.

Therefore, I, Sri Bidyut Bikash Bhagawati, ACS, District Magistrate, Hojai, in exercise of powers conferred upon me U/S 163 of Bharatiya Nagarik Suraksha Sanhita do hereby promulgate the following orders.

1. All types of vehicle having height over 3.0 mtr, vehicular movement is strictly prohibited through level crossing ST-38 of Doboka-Kampur road for 30 days from 02/08/2025 - 31/08/2025.
2. During this period, the vehicles having height less than 3.0 mtr coming from Doboka to Kampur will pass through service road.
3. During this period, the vehicles having height less than 3.0 mtr coming from Kampur to Doboka will pass through service road and cross under via-duct of the span A2-P24 of the newly constructed ROB.

Owing to the necessity of the situation, this order is passed ex-parte under section 163 of Bharatiya Nagarik Suraksha Sanhita. However, anyone aggrieved by the order may approach the competent authority for modification/ waiver of the order. This order comes into force with effect from 02/08/2025 – 31/08/2025. Any violation of this prohibitory order will be punishable U/S 223 of Bharatiya Nyaya Sanhita.
