The members present in the meeting is annexed at Annexure A



- Village Level Committees will prepare Plan & Estimate of the Schemes approved by DLC and obtain technical sanction from the competent authority and submit the same to Chairman of DLC for administrative approval.
- The District Level Committee will release the fund to the Construction Committee after receiving the demand for initial work as advance through Village Level Committee as per the guidelines.
- After notification of the Construction Committees, the Committees will open Joint Bank Account in the Nationalised Banks


